8.6.1 Does the entity expect that it will continue to have the current level of net operating cash flows for the time being and, if not, why not?

#### Answer: Yes

The Company incurred approximately \$1.5 million in one-off costs in Q3 FY23 that are not expected to be incurred in Q4 FY23. These included marketing costs for CES, legal costs in relation to new IP and trademarks, defence of trademarks, increase in audit fees and corporate structure fees including an Indepent Expert Report.

Nuheara has already increased invoicing considerably on the previous quarter with shipment of Nuheara's newly developed US FDA cleared OTC self-fitting hearing aid. This includes \$1 million of new product invoices over the past two months. Invoicing is expected to continue through the course of Q4 FY23 and importantly, cash is now being received from customers for the payment of these invoices.

8.6.2 Has the entity taken any steps, or does it propose to take any steps, to raise further cash to fund its operations and, if so, what are those steps and how likely does it believe that they will be successful?

#### Answer: Yes

At the Company's EGM on 24 April 2023, Nuheara's shareholders approved a refresh of placement capacity under Listing Rules 7.1 and 7.1a.

With the shareholder support shown in the recent refresh of capacity together with the continued growth in new sales, Nuheara believes potential future capital raises (if required) will be well supported.

8.6.3 Does the entity expect to be able to continue its operations and to meet its business objectives and, if so, on what basis?

#### Answer: Yes

Through reduced costs (directly attributable to one off costs in Q3 FY23), and an increase in cash receipts (directly attributable to an increase in new product invoices being generated).
